CEO Report - Leonard Goldberg, Founder/Head of School

 - o Day 1
 - We demonstrated that OCS has a solid collage and career readiness program in place as
 evidenced by our strong graduation rates, peer-group comparison data, Alumni
 Specialist, and partnership with The Children's Aid Society.
 - We outlined a <u>robust professional development plan</u> that includes increased collaborative learning between middle school and high school teachers, and our ongoing partnership with Engaging Schools.
 - We made a compelling argument that <u>staff turnover</u> is a problem across all NYC schools but is magnified by OCS's challenging work environment.
 - o Day 2
 - We rebuffed the DOE's assertion that OCS's <u>high attrition rates</u> were problematic and explained that we view students leaving after 8th grade as a sign of progress and evidence that we have prepared them to apply to a mainstream school.
 - We emphasized that our approach will remain focused on meeting the individual needs
 of our students, and therefore progress will look differently with regard to transitioning
 students out of OCS to mainstream schools.
 - Our closing argument: "This is a long-term project. When you take students like ours it is the most difficult thing to do in education to teach them the skills they need. What we see over time is that these students are passing the Regents and graduating. Give us the opportunity to do even better."
